1. Executive summary

In the July-September quarter, Rwanda's total trade of US\$600.1 million was made up of imports of US\$468.6 million, exports of US\$110.3 million, and re-exports of US\$21.2 million.

The table below illustrates that the third quarter registered more exports in current prices compared to the second quarter of 2012. The majority of the exports were to EAC partner countries (mainly as the first destination of exports). The total value of exports to the EAC has been the highest in the third quarter compared to the previous two quarters. On the imports side, Rwanda imported more in current price terms in the third quarter compared to the previous two quarters and the EAC share in imports was 25.8% The trade balance for Rwanda is negative at US\$337 million for Q3 2012.

2. Introduction

This is a fourth edition of the quarterly trade publication from NISR. Our quarterly publications are usually released one month after each quarter. However, due to improvements in data capturing systems, editions for the first three quarters of this year have been delayed. This publication therefore combines all three quarters of 2012. The next publication is due in January 2013.

While we are able to capture the main products exported and imported, the data does not allow us at present to have a complete understanding of the final destination of our exports. For instance, Mombasa and Dar es Salaam serve as exit ports for coffee and tea (after auctioning) and tracing the final destination of these products has proved difficult. In this publication, we will therefore be presenting the first destination of our exports instead of the final destination and the last origin of our imports instead of first origin.

The raw data for this publication has been obtained from Rwanda Revenue Authority. We follow the harmonized system of classification for products and the compilation is made following the general trade system.

The following sections will be split into:

- Overall trade
- Rwanda's trade with EAC
- Rwanda's trade with other regional trading blocks

3. Overall trade

Coffee, minerals and tea are the main exports of Rwanda in the third quarter as illustrated in the table below. The third quarter recorded the highest value (US\$ 31.4 million) of coffee exports in 2012, while tea recorded the highest value in the first quarter 2012 (US\$ 40.5 million).

In the third quarter 2012, the main exports of Rwanda were directed to the EAC partner states and the Democratic Republic of Congo. As mentioned earlier in this report, these destinations are the first point of entry for exports.

As shown in the table below, the major partners of Rwanda in imports are Asian and EAC countries. In the third quarter, imports from China (US\$ 71.5 million) had the highest value while for the second quarter it was Uganda (US\$ 68.4 million).

Africa has been the first destination of exports and re-exports of Rwanda during the first three quarters of 2012 with shares of 84.3%, 94.3% and 98.2% of total exports in the first, second and third quarter respectively.

On the imports side, Africa was leading in the first two quarters of 2012 followed by Asia, while Asia leads in the third quarter 2012, followed by Africa. Europe is the third origin of imports of Rwanda in the first three quarters of 2012.

4. Rwanda trade with EAC

Tanzania is the main destination of exports of Rwanda in the second and the third quarter of 2012 in the EAC region. On the imports side, Uganda is the main origin of imports of Rwanda for the first three quarters of 2012.

The main exports to Tanzania in the third quarter 2012 are:

- Niobium, vanadium ores, tantalum and concentrates of US\$ 18.0 million
- Coffee, not roasted, not decaffeinated of US\$ 13.7 million
- Tin ores and concentrates of US\$ 12.1 million
- Tungsten ores and concentrates of US\$ 5.5 million
- Travel sets for personal toilet, sewing or shoe or clothes of US\$ 1.5 million

The main imports from Uganda in the third quarter 2012 are:

- Cement of US\$ 15.0 million
- Vegetable fats and oils and their fractions of US\$ 7.7 million
- Palm oil of US\$ 5.8 million
- Other soap and organic surface active products in bars of US\$3.0 million
- Maize seed for sowing of US\$ 2.6 million
- Worn clothing and other worn articles of US\$ 2.2 million
- Other safflower oil (excl. crude) and fractions of US\$ 1.3 million

5. Rwanda's trade with other regional trading blocks

Regarding the trading of Rwanda with regional organizations, the trade balance of Rwanda with CEPGL and SADC is positive (that is the exports are higher than imports) for the first three quarters of 2012. For other listed regional organization, the trade balance is negative.

The main exports to CEPGL are:

- Other beer made from malt of US\$ 5.6 million
- Wheat flour of US\$ 3.3 million
- Live bovine animals, other than pure-bred breeding of US\$ 1.9 million
- Maize (corn) flour of US\$ 1.2 million
- Other non-alcoholic beverages of US\$ 0.9 million

The main exports to SADC are:

- Niobium, vanadium ores, tantalum and concentrates of US\$ 18.0 million
- Coffee, not roasted, not decaffeinated of US\$ 13.7 million

- Tin ores and concentrates of US\$ 12.1 million
- Tungsten ores and concentrates of US\$ 5.5 million

- Wheat or meslin flour of US\$ 3.3 million

6. Annex A: Technical notes

Imports: Imports are goods or services that were produced abroad or Products of foreign origin brought into the country.

Exports: Goods and services produced in one country and sent to another country to be sold.

Re-exports: The export without further processing or transformation of good that has been recorded as imports.

Re-imports: imports of domestic goods which were previously recorded as exports.

Special Trade System

The special trade system is in use when the statistical territory comprises only the free circulation area, that is, the part within which goods "may be disposed of without customs restriction". Consequently, in such a case, imports include only goods entering the free circulation area of a compiling country and exports include only goods leaving the free circulation area of a compiling country. Under the strict definition, goods imported for inward processing and goods which enter or leave an industrial or commercial free zone or customs warehouses would not be recorded since they would not have been cleared through customs for home use. The compensating products after inward processing also would not be included in exports. It has to be used as a basis for producing trade balance and foreign trade statistics as a whole. The special trade system covers the following procedures:

(a) On importation, goods which on direct importation into the statistical territory, upon leaving a depot, transit area or after transshipment, and goods which upon leaving a warehouse of free zone, are:

- declared for home use (including drawback system and goods that were accepted on temporary admission);
- accepted on temporary importation for inward processing;
- placed in industrial warehouse or industrial free zones;
- placed in customs bonded manufacturing plants or export processing zones;
- imported after temporary exportation for outward processing.

Goods put into circulation for home use after temporary importation, on leaving industrial warehouses, free zones and customs bonded manufacturing plants and export processing zones no longer fall within the special trade regime.

(b) On exportation, goods which are:

- of national origin and declared for single exit;
- exported after temporary importation for inward processing;
- exported after release from industrial warehouses or industrial free zones;
- exported after release from customs bonded manufacturing plants or export processing zones;
- on temporary exportation for outward processing.

General Trade System

The general imports provide the most comprehensive record of the goods entering the economic territory of a compiling country and increasing the stock of its material resources while general exports provide the most comprehensive record of the goods leaving its territory and thus decreasing that stock. It is recommended, therefore, that countries use the general trade system for compilation of both their import and export statistics. It covers the following goods:

(a) On importation, goods which on direct importation into the statistical territory, upon leaving a depot, transit area or after transshipment are:

- declared for home use;
- accepted on temporary admission;
- accepted on temporary importation for inward processing;
- placed in industrial warehouse or industrial free zones;
- placed in customs bonded manufacturing plants or export processing zones;
- imported after temporary exportation for outward processing;
- imported after temporary exportation for return in unaltered state;
- placed in customs bonded warehouses or commercial free zones.

(b) On exportation, goods which are:

- of national origin and declared for single exit;
- exported after temporary admission;
- exported after temporary importation for inward processing;
- exported after release from industrial warehouses or industrial free zones;

- exported after release from customs bonded manufacturing plants or export processing zones;
- on temporary exportation for outward processing;
- on temporary exportation for return in an unaltered state;
- released from customs warehouse or commercial free zones.
