QUARTERLY EXTERNAL TRADE STATISTICS (Q3 2013)

Kigali, 20th November 2013

1. KEY POINTS AND FIGURES

- In the third quarter, 2013, Rwanda's total trade of US\$ 1,509.45 million was made up of imports of US\$ 1,336.86 million, exports of US\$ 139.49 million, and re-exports of US\$ 33.10 million.
- On the imports side, Rwanda registered 196 percent increase in current price terms in the third quarter of 2013 compared to the same quarter of 2012.
- The table below summarizes the trade of Rwanda for four quarters of the year 2012 and the first three quarters of the year 2013.

2. INTRODUCTION

This is the publication for the third quarter 2013 of formal trade statistics. This publication gives also an overview of all quarters from 2012. The next publication is due in February 2014.

While we are able to capture the main products exported and imported, the data does not allow us at present to have a complete understanding of the final destination of our exports. For instance, Mombasa and Dar Es Salaam serve as exit ports for coffee and tea (after auctioning) and tracing the final destination of these products has proved difficult. In this publication, we will therefore be presenting the first destination of our exports instead of the final destination.

The raw data for this publication has been obtained from Rwanda Revenue Authority and then treated in EUROTRACE Database Management System. We follow the international standard classifications like the Harmonized Commodity Description and Coding System (HS) and the Standard International Trade Classification (SITC) which are linked to the national customs procedure codes. Furthermore, this publication follows the recommendations from the International Merchandise Trade Statistics (IMTS) of the United Nations Statistics Division (UNSD).

- Rwanda's trade with EAC
- Rwanda's trade with other regional trading blocks

3. OVERALL TRADE

Niobium and Tin ores (US\$ 43.95 million); Coffee, not roasted, not decaffeinated (US\$ 17.03 million) are the main exports of Rwanda in the third quarter of 2013 as illustrated in the table below. In the same quarter of 2012; Coffee, not roasted, not decaffeinated exports ranked first with US\$ 31.38 million.

The table below illustrates that Gas oil for automotive, light, amber for high speed engines (US\$ 792.66 million); other vehicles with diesel or semi diesel engine, cylinder > 55cc (US\$ 129.5 million) were the major imports of Rwanda during the third quarter of 2013. In the same quarter of 2012; other Portland cement imports ranked first with US\$ 17.96 million

The main re-exports of Rwanda in the third quarter of 2013 were kerosene type jet fuel (US\$ 6.36 million), motor spirit (gasoline) (US\$ 5.70 million) premium as illustrated by the table below . In the same quarter of 2012; kerosene type jet fuel re-exports ranked first with US\$ 12.32 million

In the third quarter of 2013, the main re-exports of Rwanda continued to be directed to the EAC partner states and the Democratic Republic of Congo. As mentioned earlier in this report, these destinations are mainly the first point of entry for exports (especially for Tanzania and Kenya).

As shown in the table below, the major partners of Rwanda in imports are Asian and EAC countries. In the third quarter of 2013, imports from the Arab Emirates (US\$810.31 million) were the highest in value followed by imports from Japan (US\$ 141.62 million). Imports from China came in third position with US\$ 67.82 million.

Unlike in the first two quarters of 2013, when DR Congo was leading as the destination of Rwanda's re-exports. In the third quarter of 2013 Tanzania came top of Rwanda's re-exports destination valued at US\$ 11.31 million. DR Congo came in the second with US\$ 11.31 million worth of re-exports. The table below gives us more insight on the ranking of destination of Rwanda's re-exports.

Africa continued to be the first destination of exports and re-exports of Rwanda for the period under consideration with shares of over 84 percent of total exports in all quarters. On the imports side, Africa also ranks first and it is followed by America, Asia, and Europe as illustrated below.

4. RWANDA TRADE WITH EAC

Kenya is the main destination of exports of Rwanda in the second quarter of 2013 but Tanzania was the main destination in the last three quarters of 2012 and first quarter of 2013. On the imports side, Uganda continues to be the main origin of imports of Rwanda followed by Kenya.

The main exports to Tanzania in the third quarter of 2013 are:

- Niobium, Vanadium ores, tantalum and concentrates (US\$ 43.89 million)
- Containers for compressed or liquefied gas of iron or steel (US\$ 15.87 million)
- Tin ores and concentrates (US\$ 12.53 million)
- Coffee, not roasted, not decaffeinated (US\$ 6.93 million)
- Tungsten ores and concentrates (US\$ 6.08 million)

The main imports from United Arab Emirates in the third quarter of 2013 are:

- Gas oil (automotive, light, amber for high speed engines) (US\$ 792.3 million)
- Residual fuel oils (marine, furnace and similar fuel oils) (US\$ 1.7million)
- Other mineral or chemical fertilisers, potassic (US\$ 1.1million)
- Other parts of aeroplanes or helicopters (US\$ 1.1 million)
- Telephones for cellular networks or for other wireless (US\$ 0.7 million)

5. RWANDA'S TRADE WITH OTHER REGIONAL TRADING BLOCKS

Regarding the trade of Rwanda with regional organizations, the trade balance of Rwanda with CEPGL and SADC is positive for the third quarter of 2013.

For COMESA, COMMONWEALTH, EU and ECOWAS the trade balance is negative (that is the imports are higher than exports) in the third quarter of 2013.

7. ANNEX A: TECHNICAL NOTES

Imports: Imports are goods or services that were produced abroad or Products of foreign origin brought into the country.

Exports: Goods and services produced in one country and sent to another country to be sold.

Re-exports: The export without further processing or transformation of good that has been recorded as imports.

Re-imports: imports of domestic goods which were previously recorded as exports.

Special Trade System

The special trade system is in use when the statistical territory comprises only the free circulation area, that is, the part within which goods "may be disposed of without customs restriction". Consequently, in such a case, imports include only goods entering the free circulation area of a compiling country and exports include only goods leaving the free circulation area of a compiling country. Under the strict definition, goods imported for inward processing and goods which enter or leave an industrial or commercial free zone or customs warehouses would not be recorded since they would not have been cleared through customs for home use. The compensating products after inward processing also would not be included in exports. It has to be used as a basis for producing trade balance and foreign trade statistics as a whole. The special trade system covers the following procedures:

(a) On importation, goods which on direct importation into the statistical territory, upon leaving a depot, transit area or after transhipment, and goods which upon leaving a warehouse of free zone, are:

- declared for home use (including drawback system and goods that were accepted on temporary admission);
- accepted on temporary importation for inward processing;
- placed in industrial warehouse or industrial free zones;
- placed in customs bonded manufacturing plants or export processing zones;
- imported after temporary exportation for outward processing.

Goods put into circulation for home use after temporary importation, on leaving industrial warehouses, free zones and customs bonded manufacturing plants and export processing zones no longer fall within the special trade regime.

(b) On exportation, goods which are:

- of national origin and declared for single exit;
- exported after temporary importation for inward processing;
- exported after release from industrial warehouses or industrial free zones;
- exported after release from customs bonded manufacturing plants or export processing zones;
- on temporary exportation for outward processing.

General Trade System

The general imports provide the most comprehensive record of the goods entering the economic territory of a compiling country and increasing the stock of its material resources while general exports provide the most comprehensive record of the goods leaving its territory and thus decreasing that stock. It is recommended, therefore, that countries use the general trade system for compilation of both their import and export statistics. It covers the following goods:

(a) On importation, goods which on direct importation into the statistical territory, upon leaving a depot, transit area or after transhipment are:

- declared for home use;
- accepted on temporary admission;
- accepted on temporary importation for inward processing;
- placed in industrial warehouse or industrial free zones;
- placed in customs bonded manufacturing plants or export processing zones;
- imported after temporary exportation for outward processing;
- imported after temporary exportation for return in unaltered state;
- placed in customs bonded warehouses or commercial free zones.

(b) On exportation, goods which are:

- of national origin and declared for single exit;
- exported after temporary admission;
- exported after temporary importation for inward processing;
- exported after release from industrial warehouses or industrial free zones;
- exported after release from customs bonded manufacturing plants or export processing zones;
- on temporary exportation for outward processing;
- on temporary exportation for return in an unaltered state;
- released from customs warehouse or commercial free zones.
