

# NISR hosts Expert Group Meeting on MDGs

*The National Institute of Statistics of Rwanda (NISR) hosted the Expert Group Meeting (EGM) on Use of Surveys, Censuses, and administrative data for deriving Millennium Development Goals (MDGs) Indicators.*

The conference was sponsored by the African Development Bank (AfDB) and United Nations-Economic Commission for Africa (UNECA). The timely services at Sports View Hotel where the EGM took place from 28th June -1st July, 2010 supplemented a credit on hospitality for NISR.

Mr. Mubila Maurice and Oumar Sarr, the chief statisticians represented AfDB and UNECA respectively. They both spoke about the importance of statistics as an important tool in planning for the successful and sustainability of the countries' programs and projects. The AfDB representative, in his opening remark thanked the participants for their positive turn up for this meeting in Kigali. He informed them the two main objectives of the EGM as; Evaluate the handbook on the MDGs, share experiences from different African countries on methods of measuring and monitoring MDGs, and provide collective input on the handbook. The Acting Director General/NISR

in his opening remark welcomed participants from different National Statistics Offices in Africa and assured them a peaceful stay in Kigali. He mentioned that, although there have been many challenges in producing timely and quality statistics in most developing countries, a lot has been achieved due to unflinching commitments from statisticians, partners, and Governments. He further made a brief presentation on the achievements made by NISR that most importantly, NISR has formulated the National Strategy for the Development of Statistics (NSDS) for the period of five years 2009 – 2014 in order to monitor the

government's priority programs such as EDPRS and MDGs. Development and poverty Reduction Strategy (EDPRS) that will provide the relevant indicators to be used in formulating, updating, monitoring and evaluating the strategies and targets of the country towards Vision 2020" said Murangwa, acting DG. He urged that, although there are still challenges in producing timely and quality data, dissemination, coordination, and capacity of statisticians, a lot has been achieved due to determination.

He finally wished a fruitful deliberation to the participants. In 2000 world leaders signed the United Nations Millennium Declarations, committing their countries to eight MDGs, which include halving extreme poverty, halting the spread of HIV/AIDS and providing Universal Primary Education by 2015. A number of

Statistics Offices from African countries attended the EGM, these included; Uganda, Mali, Kenya, Chad, Tanzania, Malawi,

Democratic Republic of Congo, Zimbabwe, Congo Brazzaville, Mozambique, Ethiopia, Egypt, Cameroon, Zambia, Ghana, Nigeria, Namibia, Ivory Coast, Togo, Senegal, South Africa, Rwanda, Swaziland, Tunisia, Burundi, Guinea Bissau, Zimbabwe, Morocco, Niger, Sierra Leone, and Gambia. Several scientific papers focusing on data challenges for monitoring the MDGs in African countries were presented during the conference. Every participant made a presentation on methods of measuring, monitoring, reporting, and progress made in achieving MDGs. Mugisha Roger represented NISR on the side of Rwanda. Progress



on achieving MDGs was realized in comparison with other countries although more efforts were still needed. Iro Godwin, in charge of MDGs in Nigeria Bureau of Statistics stressed that there's a need to know more about Africa and the aspects of life on the continent so that lives and circumstances of the people on the continent can be improved. "We do not count for the sake of counting. We count so our knowledge base improves. We count so that change becomes possible. We count so that policy-makers can be informed of the challenges of the past and the challenges which lie ahead".

Challenges on the progress of MDGs in most countries were almost the same. These included; lack of disaggregated data, methods of data collection, budget allocation, coordination issues and limited capacity. The last session of the workshop was drawing recommendations together which included; create MDG databases, elaborate MDGs reports, strengthen capacity, establish and strengthen administrative data, Governments to provide financial resources, disseminate MDG reports, to mention but a few. As usual, NISR hospitality was expressed through a cocktail for the participants on the last day of the conference. Statisticians from different African countries expressed their appreciation to NISR for accepting to host the EGM and also the warm hospitality showed to them during the four days spent. The representatives from the African Development Bank and that from the Economic Commission for Africa also gave

a note of thanks to the Acting Director General for accepting to host the EGM and partnership in statistics field. In his closing remark, Murangwa Yusuf, the Acting Director General/NISR acknowledged AfDB and UNECA for trusting NISR to host the EGM and for the sponsorship of the conference for its success. He further thanked all the participants for their fruitful contribution to the handbook on the MDGs Indicators and also for sharing experiences from their countries. This was an opportunity to evaluate individual's country whether the Millennium Development Goals would be attained by 2015. He pledged continuous support among institutions.

## Counting the People of Rwanda

### Why is the Census needed?

- To provide demographic and socio-economic statistics on the people of Rwanda for the Economic Development and Poverty Reduction Strategy (EDPRS), District Development Plans (DDP) and the Millennium Development Goals (MDGs)
- To know how many people live in Rwanda:
- How many men and women? How old? Where do they live?
- What do they do? How well educated? How healthy?
- To show how fast the population is growing – births, deaths, migration
- To provide linkages to other household surveys:
- Facilitate poverty mapping
- Provide sampling framework

### How will it be funded?

By February 2011, only 66.2% of these costs had been covered by committed funding, including a Government contribution in cash and in kind of \$11.2 million, and a contribution from the One UN fund to be managed by UNFPA of \$2.5 million. The costs and known funding are represented in the diagram below, which also shows vividly the funding gap that currently stands at about \$7.3 million, **required in 2012**.

### How will it be conducted?

House-to-house visits by enumerators will collect information about people living in Rwanda on Census Day – 15 August 2012. 16,500 enumerators, including one for every village (umudugudu), will visit every household in Rwanda. Final results will be published within ten months of Census Day, observing that “data delayed is data denied”.


### What will it cost?

The Census will cost \$21.3 million, for a projected population of 11 million people in 2012, around \$1.9 per person counted. For a land-locked and remote country, this is not excessive and much less per person than some other countries carrying out censuses in 2011 and 2012, e.g. Zambia and Zimbabwe; and represents a big decrease from the \$32.3 million that was estimated in the National Strategy for the Development of Statistics. The biggest cost is the enumeration itself at a cost of \$8.8 million. The costs will peak in 2012, when 59% of all expenditure will be incurred, centred on Census Day..



# Launching of the first National Strategy for the Development of Statistics (NSDS)

*The National Institute of Statistics of Rwanda (NISR) is set to provide appropriate, reliable, timely and accessible statistical information on Rwanda in a harmonized manner after the first ever National Strategy for the Development of Statistics (NSDS) was launched on 19th October, 2010 at Serena Hotel, Kigali.*



The NSDS is a tool meant to strengthen the country's entire National Statistics Systems (NSS), a combination of institutions that provide statistical information to the government and the public, for planning and decision making. "The strategy we are launching today constitutes a significant milestone in our journey towards rebuilding a credible national statistical system – we know that there remains a lot to be done but I would like to assure you of the government's commitment in this regard," John Rwangombwa, the Minister of Finance and Economic Planning, told an audience that included regional statisticians, government officials and development partners.

The acting Director General of NISR, Dr. Diane Karusisi, noted that NSDS's vision is to become an efficient information support for realizing Rwanda's vision 2020 and be recognized as a leading national statistical system in Africa. The NSDS is conceptualized to strengthen the information backbone of the EDPRS – (Economic Development and poverty Reduction Strategy), Millennium Development Goals (MDG's) Monitoring, Vision 2020 and other national development programmes.

There are five key Program areas that the NSDS shall

focus on in line with the above mentioned challenges: data production and management, dissemination, services to data users and advocacy, coordination, capacity-development and financing. Sectors will focus on developing comprehensive sector statistics frameworks that will guide statistics development in the sectors. Administrative statistics and key, rationalized sector specific surveys will be conducted. This will be done in collaboration with the NISR.

The following activities have been identified.

Censuses and Surveys:

- i. 2010 Integrated Household Living Conditions Survey (EICV 3)
- ii. 2010 Demographic and Health Survey (DHS 4)
- iii. 2010 Census of Public Servants
- iv. 2010 Manpower Survey
- v. 2011 Enterprise Survey
- vi. 2012 Census of Population and Housing
- vii. 2012 Service Provision Assessment-Health (SPA)
- viii. 2013 Agriculture Survey
- ix. 2014 Feasibility study of the Continuous Multi-purpose Survey (CMS) for more frequent poverty and multi-sectoral indicators

## Development of administrative-based statistics

i. Develop the Civil Registration System to generate Vital Statistics



ii. Develop the Integrated District Statistical System to generate consistent district level statistics that would allow comparison among districts and consolidation into sectors and national statistics

iii) Generate and develop administrative-based Statistics in all sectors in phases

iv) Development of derived indicator systems

Maintain and improve data systems to estimate/derive indicators to measure economic development and social phenomena, such as National Accounts (GDP estimation), Price Indices and Production Indices, to mention but a few.

The Minister, however, added that statistics themselves are of little value adding that it is what they are used for that makes the difference. To reinforce the existing data dissemination mechanisms, two other online tools – DevInfo Rwanda

and Intergrated Multi-sectoral Information System (IMIS-Rwanda) were launched. DevInfo is a database that focuses on development indicators. It measures the Millennium Development Goals (MDGs) and Economic Development and Poverty



Reduction Strategy (EDPRS) indicators, while IMIS-Rwanda provides online access to micro data in addition to the indicators. “These tools have the capability to analyze and present data in a variety of forms including tables, graphs and thematic maps. These two tools therefore provide policy makers, development partners and research institutions, among others, with a friendly platform for data access,” said Rwangombwa. The cost of implementing the



NSDS for five years, is estimated at \$ 80.5 million and the bill will be footed by the government and development partners. The launch was concluded with the signing of an NSDS basket fund MoU between the Ministry of Finance Represented by the Hon. John

Rwangombwa, the European Commission (EC) delegation and the DfID Head of Delegation. On behalf of development

partners, Elizabeth Carriere, the head of DFID in Rwanda, noted that the NSDS’s launch is an important step not only in the advancement of quality statistics in Rwanda but also for the development of Rwanda itself.

“Rwanda’s development partners need to be able to provide evidence that our support is

yielding results, and further, that these results are being achieved through efficient means that reflect real value for money,” she noted.

She encouraged the EC and other development partners to join DFID and the AfDB, in supporting the basket fund which will be managed by NISR. The UN Resident Coordinator Aurelien Agbenoci pledged the UN’s continued support in building up Rwanda’s statistical systems. ■

*Member states and international partners celebrated the first “World Statistics Day” on 20th October 2010.*

The professional community of official statisticians around the globe worked steadfastly in the past decades in building a global statistical system that the world relies on. It is a community united in providing high quality, reliable and impartial statistical information for evidence-based policy formulation. Reliable, timely data are crucial for economic and social development.

They allow policy makers from member states and the UN system to analyze important trends on numerous issues, such as the pace at which the world is progressing to achieve the Millennium Development Goals. Without solid information we cannot measure where we are and what needs to be done. If the world cannot get the right numbers, it cannot push for the right solutions.

Rapid technological developments offer new opportunities to collect and process a larger volume of official statistics with unprec-

edented speed. And the internet, smart phones and social networking services enable statistical services to disseminate the data to a wider spectrum of users, including policy makers, researchers, businesses, the media and the public at large. However, access to new methodologies and technologies is uneven and many developing countries are struggling to build or even just sustain their national statistical capacity in this time of economic hardships. Strengthening national statistical capacity so that all institutions have reliable data on economic and social issues must remain our highest priority.

Countries from around the globe produce and submit reliable, accurate, scientific and comparable data to the division. The result is a global statistical system based on public service, professionalism and integrity. On the first World Statistics Day worldwide national statistical experts commend the demonstration of these values. Internal Workshops and Trainings conducted in 2010. ■
