Gross Domestic Product – 2017-18

I. Gross Domestic Product and its structure

In the fiscal year 2017-18, GDP at current market prices was estimated to be Frw 7,898 billion, up from Frw 7,126 billion in previous fiscal year 2016-17. Services sector contributed 47 percent of GDP while agriculture sector contributed 31 percent of the GDP. Industry sector contributed 16 percent of the GDP and 7 percent was attributed to adjustment for taxes and subsidies on products.

II. Growth rate by kind of activity

In 2017-18, estimates calculated in 2014 prices show that GDP was 8.9 percent higher in real terms compared to 2016-17.

In this period, agriculture increased by 8 percent and contributed 2.2 percentage points to the overall GDP growth rate. Food crops increased by 8 percent and export crops increased by 14 percent.

Activities in the industry sector increased by 8 percent. Manufacturing activities increased by 8 percent boosted by food processing activities which increased by 15 percent, manufacturing of chemicals, rubber & plastic activities which grew by 8 percent, and manufacturing of textiles, clothing & leather goods which increased by 19 percent. Construction activities increased by 4 percent.

Activities in services sector increased by 10 percent. According to their weights, the main contributors were Wholesale & retail trade that increased by 14 percent due to overall increase in agriculture and manufactured goods; Transport services that grew by 19% driven by Air transport that grew by 44%; Administrative & Support services which grew by 12 percent; Financial services by 10 percent; Information & Communication by 20 percent; Professional, scientific & technical services by 6 percent and Public administration which grew by 6 percent.

III. Expenditure GDP

In 2017-18, total final consumption expenditure increased by 4 percent mainly due to an increase of 4 percent in Household final expenditure. Overall exports increased by 27 percent and total imports increased by 15 percent.
